## Taking a Step Towards Racial Equity THE CHARTER OAK STATE COLLEGE FOUNDATION

*A Call-to-Action with solutions to close the gap on disparity...and an Answer!*

**NEW BRITAIN – April 29, 2021**

The 2020 Shea Lecture Series, *Economic and Racial Disparity and Solutions*, was a collaborative effort to bring about awareness and solutions to the long-standing issues of poverty, economic, and racial disparity. The series is concluding with a call-to-action and the release of the Shea Lecture [White Paper](#), an in-depth accounting of the solutions.

The Shea Series illuminated common denominators of poverty, and the lack of equal access and equal opportunity as being paramount to improving lives. Higher Education is a leading factor in improving the economic standing of people in low paying jobs, living in poverty.

**Glenn Davis**, First Vice President, Community Development of Liberty Bank and COSC Foundation Lecture Chair, closed the series stating, "The overall objective of the Shea Lecture initiative is to provoke critical thinking and dialogue among students and the broader community concerning crucial social issues. Beyond simply being a forum for discussion, this year's forum is intended to be a *Call to Action*."

The Charter Oak State College and the COSC Foundation are responding to the *Call-to-Action* with a call for funding and support for a new program - ***Intent on improving tomorrow for Parents (of Color) -***. This program will be aimed at removing the barriers to higher education through (online) degree completion at Charter Oak State College for parents of color, married or single, living in poverty in Connecticut.

**Liberty Bank Foundation is answering the call and providing a grant of \$6,000 in scholarship funding.**

The \$6,000 will be used to provide (3) three \$2,000 scholarships to students / Parents of Color (living in poverty) for the 2021/2022 Academic Year.

The Shea Lecture provided a rich and insightful discourse presented by a distinguished panel of experts from across the state's landscape. A deep understanding into racial injustice and its adverse impact as expressed through the lenses of key economic pillars in our society, e.g., Education, Housing, Business and Community Development, Healthcare, Financial and overall well-being.
